**In response to government advice regarding the spread of the coronavirus, COVID-19, which the World Health Organisation had declared as a pandemic on 11 March 2020, the LGB of Thomas Telford UTC had not convened in the normal way for its meetings on 2 April 2020 and 6 July 2020. Alternative arrangements by which the LGB could instead continue to deal with the important business of the meeting agendas were established, taking into account several factors, including, the frequency of contact between the LGB Chair and the Headteacher, complemented by the increased inter-meeting communications which the Board had been receiving during the lockdown period. Governors had been provided with various papers, as circulated in advance, as usual and the Principal had responded to questions relating thereto and formal records have been prepared to document how the LGB continued to address the key issues of each termly agenda in the absence of the normal meeting programme.
